## OFFICIAL RULES

1. Fish must be caught on a rod and reel/pole and line during dates set for tournament by the person who entered the tournament.
2. There is only one payout per place in each category entered.
3. Live, dead, or artificial bait is acceptable.
4. Cannot fish within 300 yards of tournament headquarters (GYB Bait camp).
5. Decision of the weigh master is final.
6. Weigh in will be at the Galveston Yacht Basin bait camp during regular business hours 6 a.m.- 5 p.m. Monday thru Sunday. 715 N. holiday drive. GALVESTON , TX 77550
7. If caught when the GYB is closed weigh fish in next day.
8. Tournament boundaries are the entire gulf coast in PUBLIC WATERS, no private lakes, ponds or restricted water ways.
9. Black drum has to be 15 inches to qualify, but not more than 30 inches.
10. Captains/Guides may fish the tournament but cannot retain fish during a charter to weigh in for themselves.
11. Charter clients can enter and fish tourney.
12. Tournament entrants must register for the tournament 24 hours before entering a fish for weigh in.
13. No mutilated or altered fish.
14. Cannot catch fish in any kind of net or on a trot line.
15. All participants get a copy of rules when entering, by entering this tournament entrants release liability for tournament.
16. Tournament weigh masters reserve the right to clean any fish brought in to be weighed.
17. No refunds on tournament entry.
18. Contestants are responsible for licenses, taxes, or fees.
19. Failure to comply to rules will be automatic disqualification.
20. Tournament starts FEBRUARY 1<sup>ST</sup> at 6 a.m. and ends APRIL 1<sup>ST</sup> at 5 p.m.
21. Tournament headquarter number ( 409)- 692- 1555.
22. Any obnoxious, rude, or disruptive behavior will be grounds for disqualification, and the weigh in station, as discretion of the tournament director.
23. Any cheating will not be tolerated, and such will be disqualified.
24. In case of a tie the first person that entered a fish will have the tie breaker.
25. Fish will be weighed one time only.
26. Polygraph will be given to 1<sup>ST</sup> Place winner.

## PARTICIPANT RELEASE OF LIABILITY - READ BEFORE SIGNING

### WAIVER, RELEASE, AND HOLD HARMLESS AGREEMENT

In exchange for participation in a Galveston Yacht Basin ("GYB") tournament GYB BIG UGLY and the opportunity to win cash and prizes, I hereby acknowledge, affirm and agree to (declare) the following:

1. That the vessel that I am using in the GYB BIG UGLY has an active, valid liability insurance policy or rider with a minimum of \$100,000.00 liability coverage applicable to the boat owner, passengers, or other third parties injured as a result of any mishap involving the vessel;
2. That the act of traveling in and fishing by use of a boat in tournament situations often times presents dangerous circumstances, including, but not limited to traveling at high rates of speed; exposure to inclement weather, such as high winds, fog, rain, and extreme heat or cold; striking or grounding on submerged objects, masses, debris, or land; being in close proximity to, including collisions with, other vessels or structures; use of sharp objects, including knives, scissors, pliers, tools, hooks, lures and the like; being subjected to exhaustion, fatigue, and/or dehydration; and/or being subjected to equipment or vessel failure (e.g. outboard motor, boat hull, pumps, trolling motor, batteries and electronic devices); yet, I willfully, knowingly, and voluntarily declare that I submit my person, equipment and vessel to these conditions and assume any risk arising out of or as a result of my involvement in these circumstances. I agree to indemnify and hold harmless GYB, the GYB BIG UGLY, together with all sponsors and affiliates of the GYB BIG UGLY, their respective agents, principals and assigns (the "Indemnified Parties") with regard to any loss or damage to my person or property (including fish to be presented at weigh-in) while engaged in any act of participation in the GYB BIG UGLY, including, but not limited to, those acts during practice, captain's meetings, tournament performance and while engaged in collateral/ancillary activities of the GYB BIG UGLY.
3. That during the GYB BIG UGLY, usage and maintenance of my boat/vessel, instruments and equipment are my sole responsibility and that the Indemnified Parties GYB BIG UGLY, its principals, agents and assigns are in no way responsible for failure of my equipment or any action of mine or a third party which could result in damages or losses to my property (including live fish to be presented at weigh-in) or person, or to those same damages or losses to a third person. I agree to hold harmless GYB BIG UGLY Series, its agents, principals and assigns, as well as indemnify them in the event of a claim regarding any loss or damage to property or person arising out of my usage or maintenance of my vessel, instruments and equipment in the EVENT.
4. That I further agree to indemnify, defend and hold the Indemnified Parties harmless from and against any and all liabilities, damages, losses, expenses, claims, demands, suits, fines, or judgments that include reasonable attorneys' fees, costs and expenses, incidental thereto, which may be suffered by, accrued against, charged to or recoverable from any party, by reason of any claim arising out of or relating to any act or error or omission, or misconduct of my agents or me during the GYB BIG UGLY.
5. That I agree to waive any right to compensation or a claim against the Indemnified Parties with regard to the use of my likeness or appropriation, thereof, in any media format, whatsoever. I further agree to indemnify the Indemnified Parties against any claim by a third party involving advertisement, sponsorship, or use of other marketing methods involving said third parties or their product or services. I further agree that any media, photographs, video, audio and the like that includes the likeness of me or my sponsorship, produced by any of the Indemnified Parties is the sole property of one or more of the Indemnified Parties and I waive any right of compensation or ownership claim to said property. I acknowledge that the Indemnified Parties have the absolute authority to use my likeness in any reasonable manner deemed appropriate by the Indemnified Parties.

I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the GYB BIG UGLY OR THE INDEMNIFIED PARTIES WHETHER CAUSED BY THE NEGLIGENCE OF ANY OF THE INDEMNIFIED PARTIES. I CERTIFY THAT I AM PHYSICALLY FIT AND OTHERWISE NOT MEDICALLY DISQUALIFIED OR AT RISK WHILE PARTICIPATING IN THESE EVENTS.

I HEREBY RELEASE THE INDEMNIFIED PARTIES FROM ALL LIABILITY FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFROM ON ACCOUNT OF INJURY TO MY PERSON OR PROPERTY OR RESULTING IN MY INJURY OR DEATH ARISING OUT OF OR RELATED TO THE GYB BIG UGLY, WHETHER CAUSED BY THE NEGLIGENCE OF ANY OF THE INDEMNIFIED PARTIES.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTY BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
